Applications are invited from the candidates who are Domicile of Assam, Manipur, Meghalaya, Mizoram, Nagaland, Tripura for the post of Junior Assistant (Fire Service) NE – 4 at various airports in the above states in North – Eastern Region. The eligibility criteria for the posts are as follows:

1	Age: 30 years as on 15-09-2015	Relaxation: (i) 5 years for ST (ii) 3 years for OBC (iii) Length of service extended by 3 years for Ex - servicemen
2	Educational Qualification	a) 10 th Pass + 3 years' approved regular Diploma in Mechanical/Automobile/Fire with minimum 50% marks; OR b) 12 th Pass (Regular Study) with 50% marks
3	Driving License	a) Valid Heavy Vehicle Driving License; OR b) Valid Medium Vehicle License issued at least one year before the date of advertisement; OR c) Valid Light Motor Vehicle License issued at least two years before the date of advertisement. In case of (b) and (c), on qualifying the written test the candidates should produce a valid Heavy Driving License at the time of Driving Test. In case, the candidates fail to do so then he shall not be allowed to take Driving Test and be straightway disqualified for further selection procedure.

6	Pay Scale	Rs. 12500 – 28500/- and other allowances as per AAI rules	

Other conditions are as follows:

1	Appointment to above mentioned posts are subject to fulfilling eligibility conditions and successfully passing of Basic Training Course for a period of four months.
2	During training, incumbent is entitled for stipend as per rules.
3	The candidates will have to appear for test/interview at their own expenses. Only those candidates who qualify in the written exam will be allowed to appear in physical measurement test. The candidates will be allowed to appear in driving test/physical endurance test subject to qualifying the physical measurement test. The candidates will be allowed to appear in Interview subject to qualifying Driving Test/Physical Endurance Test. SC / ST candidates called for interview will be paid 2 nd class rail fare as per rules. In case at any stage, it is revealed that the candidate has furnished false information his candidature, irrespective of his position in selection process, would be cancelled and he will not be considered for selection/appointment.
4	The eligibility with regards to age, qualification, driving license, etc. will be determined as on 15.09.2015.
5	Employees of Govt./Public Sector undertaking should forward the application through proper channel.
6	Women are not eligible for the post.
7	Canvassing in any manner and bringing outside influence shall make the candidature liable for rejection.
8	The authority reserves the right to restrict the number & candidates to be called for test / interview on the basis of any other norms decided by the authority at a later date.

10	Applications received after due date and incomplete applications shall be summarily liable to be rejected.

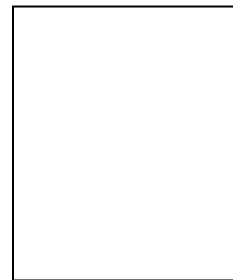
